REQUEST TO INVOKE DISCRETIONARY REVIEW





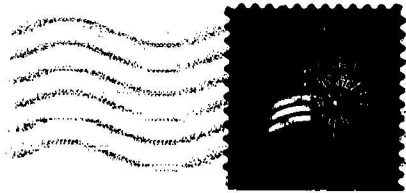
