AGREED MOTION TO ADVANCE DATE OF CASE MANAGEMENT CONFERENCE

With the agreement of complainant The Florida Bar, respondent Philip Gerson moves to advance the date of the Case management Conference and states:

1. By order dated July 21, 2016, the Court set a case management conference for 4:00 PM on Tuesday, August 23, 2016.
