

ORDER IMPOSING SANCTIONS

On August 28, 2014, the defendant filed a Motion to Correct Illegal sentence which was identical to one he filed in November of 2010. In light of this, this court entered an order denying this motion and further found that the motion was frivolous on September 10, 2014. The court allowed the defendant 45 days to show cause why sanctions should not be imposed upon him for filing a frivolous motion.

On September 30, 2014, the defendant submitted a letter to the court in which he indicated he did not understand the procedural history of his cases. Nowhere in the letter did he respond to the court's Order to Show Cause issued upon him in which the court asked the defendant to explain why he filed two identical motions to correct illegal sentence.

It is clear, both from his having filed the frivolous motion, and from his letter, that the defendant is unconcerned with wasting judicial resources. In accord with *Duncan v. State*, 728 So.2d 1237 (Fla. 3rd DCA

1999), this court hereby orders the defendant not to file any future pleadings with this court unless said pleadings are submitted by an attorney properly licensed to practice in the State of Florida.

Consistent with this, the court directs the Clerk of Court for the Eleventh Judicial Circuit to reject any future pleadings from this defendant unless they are submitted by a lawyer licensed in the State of Florida.


