SUPPLEMENT TO EMERGENCY PETITION FOR WRIT OF QUO WARRANTO AND MANDAMUS AND EMERGENCY REQUEST FOR ORDER DELAYING PRINTING AND DISTSRIBUTION OF ABSENTEE BALLOTS

Petitioner, PEDRO DIJOLS, as candidate for Broward County Judge Circuit Group 3, files this Supplement to his Emergency Petition for Writ of Quo Warranto and Mandamus and Emergency Request for Order Delaying Printing and Distribution of Absentee Ballots, and states:

Pursuant to state election law, the supervisor of elections must send absentee ballots overseas by Saturday, September 20, 2008. On September 15, 2008, Mary Cooney, a spokesperson for the Supervisor of Elections, Dr. Brenda Snipes, informed the press that they will not wait until the

determination of this action, or the action filed in circuit court pursuant to § 102.168, Fla. Stat., to print the ballots for Broward County. The ballots will therefore be printed with Mardi Levey's name on them.

The printing of the ballots for Broward County with Mardi Levey's name on them renders this action, as well as the election contest action filed in circuit court, futile, and vitiates any effective remedy. The decision by the Supervisor of Elections to print the ballots with Mardi Levey's name on them deprives Petitioner of his statutory right to contest the election results. Such action also makes a mockery of the Florida Election Code and renders the Election Contest Statute useless. There will be irreparable injury to the electorate and election process if the absentee ballots are incorrect. Conversely, there will be no injury to any party or the voters of Broward County if there is a slight delay in the printing and distribution of the absentee ballots so that the issue can be presented and resolved by this Court.

All evidence in support of PEDRO DIJOL's Emergency Petition is stated in public records contained in Petitioner's Appendix. Thus, no evidentiary hearing is necessary. Because of the urgency of this matter and the timeframes involved, Petitioner, PEDRO DIJOLS, respectfully petitions

this Court for an order delaying the printing of the ballots and distribution of the absentee ballots for Broward County until such time as this expedited matter is resolved.
