APPELLANT'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO SERVE INITIAL BRIEF

Appellant, State of Florida, respectfully moves for an order extending the time for service of its initial brief through Friday, July 22, 2011. In support of this motion, Appellant states:

- 1. The State of Florida filed this appeal on June 10, 2011, and its initial brief is currently due to be served on July 1, 2011.
- 2. This appeal presents several complex issues arising under the United States Constitution involving the constitutionality of section 316.3045, Florida Statutes. This statute limits the distance at which noise from soundmaking devices operating within a motor vehicle can be heard outside of the vehicle.

- 3. During the 20-day period between the time the appeal was filed and the due date for the current brief, undersigned counsel do not have sufficient time needed to complete the initial brief due to their representation in a major constitutional challenge to Florida's education system that is set for oral argument at the First District Court of Appeal on June 30, 2011, work-oriented travel, prearranged vacation schedules, and other matters in litigation in trial and appellate courts that have required immediate attention.

- 7. This request is made in good faith and not for purposes of delay. No prejudice will result from the extension sought.
