PETITIONER'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO SERVE INITIAL BRIEF

Pursuant to Florida Rule of Appellate Procedure 9.300, Petitioner Amanda Jean Hall moves the Court for an extension of time to serve her initial brief, and states:

- 1. This case is before this Court for its discretionary review of a question certified to be of great public importance by the First District Court of Appeal.
