If filed by a non-lawyer or a lawyer not licensed to practice in Florida, the response must be in the form of a signed original letter that is mailed or hand-delivered to this Court; no additional copies are required or will be accepted.

The Standing Committee on the Unlicensed Practice of Law is directed to file a brief in response to any briefs and responses filed, on or before July 8, 2013. The Real Property, Probate & Trust Law Section of The Florida Bar as well as any interested party that filed a response may file a reply, in accordance with the


