(Refiled to correct title of motion)

On 25 September 2015, this Court ordered the respondent to show cause why this Court should not accept jurisdiction in this case, summarily quash the decision being reviewed, and remand for reconsideration in light of the Court's decisions *Henry v. State*, 40 Fla. L. Weekly S147 (Fla. Mar. 19, 2015), and *Gridine v. State*, 40 Fla. L. Weekly S149 (Fla. Mar. 19, 2015)

In its 27 October 2015 response, the respondent requested that this Court either stay the proceedings until expiration of the time for the respondent to petition the United States Supreme Court for a writ of certiorari in *Henry*, 40 Fla. L. Weekly S147, and/or *Gridine*, 40 Fla. L. Weekly, or remand to the trial court for proceedings in accordance with sections 775.082 and 921.1402, Florida Statutes. The respondent styled the request for stay as it did because it was still reviewing whether to petition for writ of certiorari.
