PETITION FOR DISCIPLINARY REVOCATION WITH LEAVE TO REAPPLY FOR READMISSION

COMES NOW the petitioner, Randall Norman Thornton, and files this Petition for Disciplinary Revocation pursuant to Rule Regulating Fla. Bar 3-7.12 and states:

- 1. Petitioner knowingly and voluntarily files this petition with full knowledge of its effect.
- 2. Petitioner is 66 years old and has been a member of The Florida Bar since May 10, 1974, and is subject to the jurisdiction of the Supreme Court of Florida and the Rules Regulating The Florida Bar.
- 3. The petitioner has no discipline history with the Florida Bar and has never been the subject of criminal proceedings.

- 4. The following disciplinary charges are currently pending against the petitioner:
- In contravention of a number of Bar Rules, over the last several Α. years, I mishandled monies from a number of real estate closings under the mistaken belief that a separate "seed" account I set up to handle disbursements was sufficient. During the course of an audit from The Florida Bar I was made aware of \$6,228.64 in improper disbursements. I made refunds from personal funds for all but \$32.40 in March 2013 to the parties that were properly entitled to those funds. I should have made those reimbursements much earlier to the clients entitled to those funds. I sincerely regret these actions, and appreciate the importance of maintaining accurate trust account records. I now realize I was not in substantial compliance with the Bar's Rules governing trust accounts, and tendet my disciplinary revocation. I have had no disciplinary record in my more than forty (40) years of practice. I am closing out all pending files so that no clients are adversely affected, and will withdraw from all active cases by the end of November, 2013. I am closing my practice and have taken no new cases since I learned of the final results of the Bar's audit in early October, 2013.
- 5. In mitigation and as evidence of my community pro bone service over the years, I would like to advise the court that I have served two terms as Trustee

of Lake Sumter Community College, served as Chairman of Board and President and Secretary of LSCC Foundation, served on Board and as President of SCARC, Inc. numerous times and as pro bono corporate attorney and attorney for developmentally disabled clients of SCARC. Additionally I have served on Boards of Hospice and Lake-Sumter Community Mental Health. I am a member of Wildwood Rotary Club, served as President twice, Secretary, Treasurer and past Assistant Governor for District 6980, Paul Harris Fellow plus 7. I have provided pro bono services in guardianship, estate planning, probate, marriage dissolution, boundary disputes and other legal matters to many people. Additionally, I have incorporated many charitable organizations, churches, cemeteries, and handled transfer of property for same without charge. I also enclose letters from a number of community representatives attesting to my service. Again, I am embarrassed by my failure to properly follow the Rules relating to my Trust Account, and hopefully have made it right as a result of the reimbursements.

- 6. This revocation will not adversely affect the public interest, the purity of the courts, nor hinder the administration of justice nor the confidence of the public in the legal profession.
- 7. The petitioner agrees to reimburse the Clients' Security Fund of The Florida Bar for any and all payments imposed as a result of his defalcations.

- 8. The petitioner agrees to reimburse The Florida Bar for the costs incurred in his disciplinary cases.
- 9. The petitioner agrees to permit the bar to audit any and all trust accounts and any other accounts over which has signatory as either an attorney-at-law, fiduciary, or trustee.
- 10. The petitioner has provided The Florida Ban with a sworn financial affidavit.
- 11. The petitioner shall notify the bar of any change of address during a two year period to be computed from the date of the entry of this court's order accepting this petition for disciplinary revocation. Further, the petitioner shall keep the bar advised as to the physical address of petitioner's home and/or business in the event the petitioner should utilize a post office box or other type of mail drop service.
- 12. The petitioner understands that the granting of this petition by the Supreme Court of Florida shall serve to dismiss all pending disciplinary cases.
- 13. In order to provide time for petitioner to close his practice and protect his client, petitioner has ceased accepting clients and agrees to accept no new clients from date this petition is executed and further agrees to cease practicing law by on or before November 30, 2013.

WHEREFORE, the petitioner respectfully requests this Honorable Court to grant the petition herein as follows:

A. That the petitioner's membership in The Florida Bar be revoked, with revocation to take effect on November 30, 2013.

It has been my privilege to be not only a friend but to have worked closely in a professional capacity with Randall Thornton for almost 40 years. I have known Randall since before he completed law school and I completed my education and became a CPA. During our years of association I have watched Randall not only practice law but work within our community in numerous charitable activities. He has been a tireless worker in our local Rotary Club and has contributed to most any charitable activity he has been asked to help. Organizers of all of our local fundraising projects know that they can go to Randall for help with their particular project. The help will come from not only his pocket but many times from his hours of service. Randall acted as our County Attorney for over 20 years during the time in which our county transformed from a rural county to what it has become today as a result of The Villages development which now has approximately 100,000 residents and is still growing. During this time he acted as a legal advisor to our County Commission which was faced with hard decisions about the changes taking place within our community.
