**TERRA MANAGEMENT SERVICES, INC.'S MOTION FOR ENLARGEMENT  
OF TIME**

Interested Party, Terra Management Services, Inc. (hereinafter "Terra"), moves this honorable court to extend by thirty (30) days the time within which it may file a Reply Brief to portions of the Responsive Brief filed by the Standing Committee on the Unlicensed Practice of Law on August 14, 2013. If this Motion is granted, the new filing deadline will be September 13, 2013. As good cause for the requested extension, Terra states the following:

1. Pursuant to Rule 10-9.1(g)(3) of the Rules Regulating The Florida Bar, "...interested persons having leave of court may file a reply brief within 10 days of service of the responsive brief. At its discretion, the court shall permit reasonable extension of these time periods."

2. Additional time is required within which to prepare a substantive, comprehensive reply to the complex issues raised in the Standing Committee's Responsive Brief.
3. Terra has not previously requested or received an enlargement of time within which to file a Reply Brief.
4. There will be no prejudice to the Standing Committee, Petitioner, or interested parties should the Court grant Terra's Motion for Enlargement of Time.
5. Terra has contacted counsel for both the UPL Standing Committee and the Petitioner and has been advised that there is no objection by either party to the requested enlargement of time.
6. This Motion is made in good faith and not for purposes of delay.
