**INTERESTED PARTY, CAI'S, UNCONTESTED MOTION FOR  
ENLARGEMENT OF TIME TO FILE REPLY**

---

Interested party, Community Associations Institute (“CAI”), moves this honorable court for an enlargement of time to file its Reply Brief to the Answer Brief filed by the Standing Committee on the Unlicensed Practice of Law on August 14, 2013, and requests a twenty (20) day extension that would make its response due on September 13, 2013. Neither the UPL Standing Committee nor the Petitioner has any objection to the requested extension. CAI states the following in support of this motion:

1. Pursuant to the court’s May 28, 2013, Amended Order, “any interested party that filed a response may file a reply . . . to the Standing Committee’s brief within 10 days of service of the committee’s brief.”
2. However, Rule 10-9.1(g)(3) of the Rules Regulating the Florida Bar, provides that “[a]t its discretion, the court shall permit reasonable extension of these time periods.”

3. Additional time is required to draft a meaningful Reply Brief and to allow CAI to approve the Reply Brief through the appropriate channels and committees.
4. This Motion is made in good faith and there will be no prejudice to the Standing Committee, Petitioner, or other Interested Parties should the court grant CAI's Motion for Enlargement of Time.
5. Neither the UPL Standing Committee nor the Petitioner objects to the extension requested.

WHEREFORE, CAI requests this honorable court grant a twenty (20) day extension to file its Reply Brief, with the new deadline being September 13, 2013.
