STATEMENT OF THE CASE AND FACTS

This is in response to the Motion of September 15, 2014 by Real Property and Trust Law Section of the Florida Bar "for leave to provide a supplemental brief."

SUMMARY OF THE ARGUMENT

On July 28, 2014 the Bar filed a modified opinion addressing the issues of recently passed legislation. Filing # 16397562 Electronically Filed 07/28/2014 11:00:39 AM BRIEF OF THE FLORIDA BAR.

Now the Bar comes, 49 days later, requesting additional time to present additional arguments that will do nothing to change the arguments, briefs and submissions already provided.

This untimely attempt to impose upon the authority and responsibility of the Florida legislature is unwarranted and should be dismissed.

The Real Property, Probate and Trust Law Section of the Bar originally requested the opinion of the Standing Committee on the Unauthorized Practice of Law of The Florida Bar March 28, 2012.

During the ensuing 30 months there have been enumerable testimonies, briefs, discussions, legislative initiatives, committee hearings and the resultant adoption of relevant amendments to Florida Statutes that bring us to the current circumstances.

Please forgive this reiteration of the history of this issue but even before and since The Florida Bar re: Advisory Opinion-Activities of Community Association Managers, 681 So.2d 1189 (Fla. 1996) there have been NO cases of community association manager unlicensed practice of law that have been prosecuted.

Now comes the Bar's attempt to negate the authority of the legislature and overturn the democratic process that is the basis of law.

- 2. The Bar, on July 28, 2014, did as requested by the Court, June 26, 2014, by submitting, without reservation or qualification, a supplemental brief in response to the adopted legislation.
- 3. In the July 28, 2014 brief the Bar presented their opinions and arguments for and against the law as amended.
- 4. The Section in this regard is attempting to overrule and renounce the authority of the Committee.
- a) To quote in part, "the committee failed." The disclaimer by the Bar that their own submittals are lacking and incomplete can only serve to discredit their entire argument.
- b) Again the Section discredits their own Committee's assertions, "the committee fails to consider."

The assertion that the Court would benefit from additional "supplemental" information is an attempt at additional delay for this long overdue decision.

We submit that the Bar must address their arguments to the Legislature and allow Florida statutes to do as they are designed, to serve the best interests of the citizens.
