**UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE REPLY TO
RESPONDENT'S RESPONSE TO ORDER TO SHOW CAUSE**

COMES NOW the undersigned Special Counsel for the Florida Judicial Qualifications Commission and hereby files this Unopposed Motion for Extension of Time to File Reply to Respondent's Response to Order to Show Cause and for grounds submits the following:

1. The Hearing Panel of the Florida Judicial Qualifications Commission (JQC) filed its Findings of Fact, Conclusions of Law and Recommendations with this Court on June 9, 2016, consisting of twenty-four (24) pages.

2. On June 10, 2016, this Court issued an Order to the Respondent directing her to show cause why the recommended action should not be granted, and ordered Respondent to file her response on or before June 30, 2016.

3. On June 24, 2016, Respondent filed an Unopposed Motion for Extension of Time to File a Response to the Order to Show Cause.

4. This Court granted Respondent's Motion and ordered her to file her response on or before August 1, 2016. All other times were extended accordingly. The JQC's reply is due on or before August 21, 2106.
