

**NOTICE OF VOLUNTARY DISMISSAL**

The Florida Judicial Qualifications Commission hereby files a voluntary dismissal of the charges against Judge Mark Hulsey, III, pursuant to Rule 1.420, Florida Rules of Civil Procedure prior to the final hearing before the Hearing Panel. Alternatively, the Commission seeks dismissal under Rule 9.350(b), Florida Rules of Appellate Procedure. 
