Counsel shall confer and be prepared to discuss with the Chair and make commitments concerning the following:

1. The time necessary for pretrial discovery (keeping in mind these cases are ordinarily placed on a fast-track and expedited, **see JQC Rule 11**).
2. The witnesses to be called and exhibits to be introduced.
3. A good faith estimate of the length of time required to try the parties' respective cases at final hearing.
4. The time necessary for any motions to be heard prior to final hearing.

5. Any further amendments to charges or defenses.
