- 1. The time necessary for pretrial discovery (keeping in mind these cases are ordinarily placed on a fast-track and expedited, **see** JQC Rule 11).
  - 2. The witnesses to be called and exhibits to be introduced.
  - 3. A good faith estimate of the length of time required to try the parties' respective cases at final hearing.
  - 4. The time necessary for any motions to be heard prior to final hearing.

5. Any further amendments to charges or defenses.

Policy on Limitation of Character Witnesses. Pursuant to the General Policy of the Hearing Panel, the parties are notified that at the final hearing, the Respondent Judge will be limited to a total of three live character witnesses. The Hearing Panel will otherwise consider affidavits as to characters filed by the Respondent Judge.
