Appellee, City of Marathon, by and through its undersigned counsel and pursuant to applicable law, files this Joint Unopposed Motion for Enlargement of Time to file the City of Marathon and State of Florida's Joint Jurisdictional Brief, and states as follows:

1. On behalf of the City of Marathon ("City"), and its co-Appellee the State of Florida ("State"), the undersigned counsel files this motion for a fourteen-day enlargement of time for Appellees to serve their Joint Jurisdictional Brief with this Court.

2. As grounds therefore, Appellees state that both the City and State's counsels' prior scheduling commitments do not allow for the completion of the Jurisdictional Brief before the current deadline and require the Appellees to seek the extension. In order to maintain a consistent briefing schedule, the parties have agreed to extend the deadline for all subsequent pleadings, if applicable.

3. In accordance with Florida Rule of Appellate Procedure 9.300, Counsel for the City of Marathon contacted counsel for the Appellant who kindly indicates that Appellant agrees to the requested extension.

5. Appellant will not be prejudiced by the extension of time sought by Appellees.
