PETITIONER'S UNOPPPOSED CORRECTED¹ MOTION TO SUPPLEMENT THE RECORD WITH VISIBLE COPIES OF PHOTOGRAPHIC EVIDENCE IN THE RECORD

Petitioner, Luis Torres Jimenez, pursuant to Florida Rule of Appellate Procedure 9.200(f)(1), hereby requests the Court to permit him to supplement the record with a copy of a trial exhibit containing visible copies of the photographic images contained within it. The photographs are not visible in the copy of the exhibit that presently appears in the record.

1. This case arises from the City of Aventura's issuance of a red-lightcamera traffic citation to Petitioner for making a right-hand turn at a red light.

¹ Petitioner's original motion filed earlier today did not include Exhibit B referenced herein. This corrected motion contains both Exhibits A and B as attachments, but otherwise remains unchanged from the original motion.

2. At trial, the City introduced a composite exhibit containing copies of the Notice of Violation ("NOV") and Uniform Traffic Citation ("UTC") which had been sent to Petitioner. Record ("R.") 778-80; 1340-1343. The NOV and UTC each features three photographic images: two of the vehicle at the intersection (the "A-Shot" and "B-Shot") and the license tag of the vehicle. *See* R. 778-80. The City's exhibit also included its Violation Evidence Report containing larger copies of those photographs. *See* R. 781-84. The trial court admitted these documents, along with a record custodian affidavit. *See* R. 777-87.

3. While the NOV, UTC, and Violation Evidence Report are in the record, the photographs contained in these documents appear only as black boxes, presumably because they were scanned with low resolution when they were reproduced for inclusion in the record on appeal. A copy of the existing composite exhibit from the record is reproduced as Exhibit A hereto.

4. With the assistance of the City, Petitioner has since obtained a duplicate copy of the composite exhibit with photographs that can be seen. It is attached as Exhibit B hereto.

5. Petitioner's counsel has conferred with counsel for both the City and Attorney General of Florida, and they do not oppose this motion.

WHEREFORE Petitioner respectfully requests the entry of an Order

permitting supplementation of record on appeal with the documents attached as

Exhibit B hereto.
