Petitioner, Luis Torres Jimenez, hereby gives notice that a notice to invoke this Court's discretionary jurisdiction was recently filed in the Second District in the matter of *City of Oldsmar v. Trinh*, No. 2D15-4898, 41 Fla. L. Weekly D2435a (Oct. 28, 2016). The Second District's decision in *Trinh* bears significant relationship to the decision in the instant case in that it also passes on the lawfulness of a local government's private outsourcing of its statutorily mandated responsibilities for the enforcement of Florida's red-light camera traffic laws. Both the Third District in this case and the Second District in *Trinh* reached a different conclusion than the Fourth District in *City of Hollywood v. Arem*, 41 Fla. L. Weekly D1753 (July 27, 2016), on this question, with the Third District

certifying three questions of great public importance and the Second District certifying conflict with the Fourth District in *Arem*.

Additionally, undersigned counsel would note that they represent the petitioners in both this case and in *Trinh* and that the respondents and their counsel are the same in both cases.
