UNOPPOSED MOTION FOR EXTENSION OF TIME TO
FILE REPLY TO RESPONDENT'S RESPONSE TO THIS COURT'S
ORDER TO SHOW CAUSE

COMES NOW Petitioner, MICHAEL ROHRBACHER, by and through its undersigned counsel, and hereby files this Unopposed Motion for Extension of Time to File his Reply to the Respondent's Response to this Court's Order to Show Cause, stating as follows:

1. On December 21, 2015, the Petitioner filed a Notice of Invoking this Court's Jurisdiction seeking review of an Order from the Fifth District Court of Appeal that reversed the Eighteenth Judicial Circuit's finding that Rohrbacher was entitled to a contingency risk multiplier.

2. This matter was stayed pending this Court's ruling in *Joyce, et al. v. Federated National Insurance Company*, Case No. SC16-103.

On November 8, 2017, this Court entered an Order directing the Respondent to show cause, on or before November 27, 2017 why this Court should not accept jurisdiction in this case, summarily quash the decision being reviewed, and remand to the district court for reconsideration in light of its decision in *Joyce, et al. v. Federated National Insurance Company*, No. SC16-103, 2017 WL 4684352 (Fla. Oct. 19, 2017).

4. The Petitioner was given until December 7, 2017 to file a Reply.

5. Due to various scheduled trial, appellate, work and personal commitments, responsibilities, and conflicts of the undersigned counsel, that have inhibited, and will continue to inhibit, the preparation of Petitioner's Reply in any period of time less than 10 days, Petitioner is requesting a 10-day extension of time to prepare and file its Reply up to and including December 17, 2017.

6. This enlargement of time is filed in good faith and not for the purpose of delay and will result in no prejudice to the Respondent.

7. In accordance with Florida Rule of Appellate Procedure 9.300, the undersigned has conferred with Respondent's counsel who indicated that there is no objection to the extension requested herein.

WHEREFORE Petitioner, MICHAEL ROHRBACHER, respectfully requests that this Court grant its Unopposed Motion for Extension of Time, allowing Petitioner an additional ten (10) days, or up to and including December

17, 2017, to file its Reply to the Respondent's Response to this Court's Order to Show Cause.
