RESPONDENT'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE ANSWER BRIEF

Respondent, PETER HERMAN, through counsel, pursuant to Florida Rule of Appellate Procedure 9.300, requests an extension of time within which to file his Answer Brief, and as grounds states the following:

- 1. Complainant, The Florida Bar, filed its Notice for Review on February 19, 2021.
- 2. The Bar filed an Agreed Motion requesting an additional 14 days to file its Initial Brief, which was granted by the Court on March 19, 2021.
 - 3. The Florida Bar served its Initial Brief on April 5, 2021.
