Writ of Error Coram Nobis

Comes now Bruce Toski (hereinafter 'petitioner'), self-governed and sui generis, to submit the following Writ of Error Coram Nobis in regards to the clerk's blatant mis-handling of the petitioner's filings in the case sub-judice.

The Emergency Petition was received by this Court on 09-11-2018.
On 09-14-2018 the petition was assigned case # SC18-1540.
No filing fee was charged pursuant to the Memo of Law submitted by the petitioner.

On 10-01-2018 petitioner submitted a "Judicial Notice for Correction" which has been ignored by the clerk. The clerk "John A. Tomasino" continues to inscribe the petitioner's name in ALL CAP LETTERS on all the paperwork he generates as well as the envelopes he mails them in. The clerk is well aware by now, that "BRUCE TOSKI" is a separate judicial person than the self-governed man who advances the petition herein. This blatant fraud on the court will not be tolerated.

Three months have now passed. None of the respondents have filed any responsive pleadings. There is no evidence that the Emergency Petition was ever afforded emergency status, nor that it was ever advanced to any of the justices of the Supreme Court for the People of Florida.

On 11-06-2018 a two page document was e-filed by the clerk of this Court. He took it upon himself, without any basis in law or equity, to dispose of the Emergency Petition by transferring it back to a lower court; which previously failed to act on these critical issues.

The clerk's document cited a case - [Harvard v. Singletary](#) - which is clearly distinguishable.

Harvard's petitioner:

- 1) Raised "substantial issues of fact."
- 2) Presented an individual issue which did not require settlement by the COURT.
- 3) Did not present any issue "significant to the state of the law in Florida as a whole".

This Petition:

- 1) Does not require the Florida Supreme court to determine any issues of fact whatsoever.
- 2) Presents several general issues which DO require settlement by the COURT (ignored by ALL lower courts).
- 3) Presents several issues "significant to the state of the law in Florida as a whole".

On 11-09-2018 the petitioner responded to the clerk's two page notice. Petitioner strongly suggests that all documents be forwarded - for review - to Chief Justice Charles Canady or maybe to Justice Barbara J. Pariente (she is the only justice remaining who was part of the [Harvard](#)

One month later, on 12-14-2018, the clerk, again, took it upon himself to RULE on the petitioner's demand for a hearing. He denied the petitioner's demand, summarily, without any legal or lawful authority, explanation, rationale, justification or basis in law, whatsoever.

Clearly, the Court's fiduciary duty to the petitioner - as one of the People of Florida - has been abrogated. Justice delayed is justice denied.

Accordingly, petitioner addresses the full court and brings these errors into the light. The clerk is instructed to pass a copy of this Writ to every justice of the Supreme Court for the People of Florida for an en banc decision on the matters at bar.

Time is of the Essence for resolution of this matter.
