It is well known in legal circles that the display of a name in ALL CAPS designates a fictitious legal entity. These civil statutory PUBLIC ‘persons’, when used in place to indicate a living soul are often referred to as ‘strawmen’.

When any court displays a petitioner’s name in ALL CAPS they have effectively changed the legal persona from a living soul to a strawman.

At the root of this petition and one of the main reasons for it’s submission, is the unlawful attack by the respondents against my strawman and their refusal to serve the registered agent for said strawman. Instead they served a summons on Richard, a living soul, who, legally speaking, can not speak for the strawman being sued, since, fictitious legal entities (strawmen) can only be represented, in court, by an attorney.
