TRIAL COURT REPORT DETAILING CURRENT STATUS OF THE RECORD
PREPARATION FOR APPEAL FOLLOWING STATUS CONFERENCE HEARING

THIS MATTER is before the Court on the Defendant's Appeal to the Florida Supreme Court of his Rule 3.851 Motion. Having considered said Motion, court files and records, the Florida Supreme Court's Order in Case No. SC18-340 issued March 5, 2018,¹ the status conference hearing held April 2, 2018, and being otherwise fully advised, this Court finds as follows:

On April 2, 2018, the trial court held a status conference hearing as to the appellate record.
