REQUEST FOR PRODUCTION OF DOCUMENTS OR OTHER EVIDENCE

COMES NOW the Respondent, VEGINA T. HAWKINS (hereinafter "HAWKINS"), by and through undersigned counsel, and pursuant to Fla. R. Civ. P.1.350(a) hereby requests that the Florida Judicial Qualifications Commission (hereinafter "FJQC") produce for inspection, examination and copying at the offices of J. David Bogenschutz & Associates, P.A., within thirty (30) days, or at such time and place as may be agreed upon between counsel, the original or, if the originals are unavailable, copies of all documents hereinafter described in the possession, or custody of the FJQC.

"Documents" shall mean and be read to include any written or graphic matter or other means of preserving thought or expression, and all tangible things from which information or thought can be processed or transcribed, and all copies containing any additional matter, however produced or reproduced, of any kind and description, in the FJQC's actual or constructive possession, custody care or control, and which pertains directly or indirectly, in whole or in part, either to any of the allegations of the Notice of Formal Charges. "Documents" shall further include, but not be limited to, correspondence,

transcripts, memoranda, notes, photographs, messages, letters, telegrams, teletyped messages, diaries, minutes, books, reports, charts, ledgers, invoices, computer memory, word processing data, computer printout, e-mails, legal pleadings, case law, newspaper magazine articles, stories or clippings, affidavits, statements of witnesses, tape recordings or other items expected to be utilized at hearing herein.

Requests for Production

1. All documents or items provided to the Investigative Panel pertaining to the instant proceedings;
2. All documents or items that will be introduced as exhibits at the hearing on the Notice of Formal Charges;
3. Witness statements of all persons interviewed by the FJQC in the Notice of Investigation;
4. Any documents or items pertaining to each of the interrogatories;
5. The statement of Judge Hawkins before the Investigative Panel;
6. All videotapes, or copies thereof, of proceedings conducted in the adjacent courtroom of Judge Hawkins and Judge Tarlika Navarro on June 11, 2019, between the hours of 9:30 a.m. and 2:00 p.m.; include herein all videos in existence of the hallway and place where the incident took place;
7. All personnel, disciplinary or other employment records of any witness to the Incident set forth in the Notice of Formal Charges who is an employee of the Court

Administration of the 17th Judicial Circuit, and any work or personal evaluation made concerning each witness, including but not limited to complaints about the job performance of each.
