**SECOND UNOPPOSED MOTION FOR EXTENSION OF
TIME TO FILE ANSWER BRIEF**

Respondent, the State of Florida, hereby moves for a 7-day extension of time to file its answer brief. *See* Fla. R. App. P. 9.300(a). This is the State's second request for an extension. The grounds for the request are:

1. This Court accepted jurisdiction on June 25, 2020.
2. Petitioner filed his initial brief on August 12, 2020. The brief was initially due on July 15, 2020, but Petitioner obtained a 30-day extension.
3. The State's answer brief is currently due today, October 12, 2020.
4. The State previously obtained a 30-day extension, but it requires an additional 7 days to complete the brief.
5. The State has substantially completed the brief, but additional time is required to complete the Office of the Solicitor General's internal review process.
