Pursuant to Rule 9.370(d), of the Florida Rules of Appellate Procedure, notice is given that, should the Court accept jurisdiction of this case, Apalachicola Riverkeeper, Calusa Waterkeeper, Collier County Waterkeeper, Emerald Coastkeeper, Indian Riverkeeper, Kissimmee Riverkeeper, Lake Worth Waterkeeper, Matanzas Riverkeeper, Miami Waterkeeper, St. Johns Riverkeeper, Suncoast Waterkeeper, and Suwannee Riverkeeper (“Waterkeepers Florida”) will seek leave to file an amicus brief in support of the Petitioner, The City of Coral Gables. Waterkeepers Florida represents the above-mentioned, independently incorporated, non-profit Waterkeeper organizations in the State of Florida.
