**RESPONDENT’S MOTION FOR EXTENSION OF TIME  
TO FILE CROSS-REPLY BRIEF**

Respondent, WENDELL LOCKE (the “Respondent”), through counsel, moves this Court to extend the deadline to November 19, 2021, for him to file his Cross-Reply Brief, and states:

1. The deadline to file the Cross-Reply Brief is November 1, 2021.

4. This motion is filed in good faith and not for the purpose of delaying this proceeding. No party will be prejudiced by the relief sought herein.

WHEREFORE, the Respondent respectfully requests that this Court extend the deadline for the Respondent to file his Cross-Reply Brief to November 19, 2021.
