**REPLY TO COMPLAINANT’S RESPONSE TO MOTION FOR EXTENSION OF TIME TO
FILE INITIAL BRIEF**

Pursuant to Rule 3-7.7, Florida Rules Regulating the Florida Bar, Respondent hereby submits his Reply to Complainant’s Response to Motion for Extension of Time to File Initial Brief, and as grounds therefore, Respondent states:

1. Respondent paid for the transcripts of this action on September 14, 2021, for over \$5,400.
