The Florida Bar's Rules of Judicial Administration Committee (Committee) and Ad Hoc Joint Subcommittee (Ad Hoc Subcommittee) have submitted to the Florida Supreme Court a report proposing new Florida Rule of Judicial Administration 2.423 ("Marsy's Law" Crime Victim Information Within Court Filing). The proposed new rule addresses the confidentiality of victim information.

The Court invites all interested persons to comment on the proposed amendments, which are summarized by the Committee and Ad Hoc Subcommittee below and reproduced in full online at https://www.floridasupremecourt.org/Case-Information/Rules-Cases-Proposed-Amendments. The Committee and Ad Hoc Subcommittee Chairs have until January 25, 2021, to file a response to any comments filed with the Court.
