The proponent of any change and any party filing a comment with the Committee prior to the filing of the report or with this Court are invited to participate in oral argument, provided a proper request for oral argument is filed with this Court on or before Tuesday, April 20, 2021. If a party wishing to participate has already filed a separate request for oral argument pursuant to this Court's publication notice, no further action is needed.

The allocation of time must be agreed upon by the parties and shared by any interested parties who have requested oral argument. The parties must notify the Clerk of Court no later than Monday, May 10, 2021, how the time is to be divided.


