The Task Force on Distribution of Iota Funds has proposed many changes to Rule Regulating the Florida Bar 5-1.1(g). Its proposal has generated comments from over a dozen non-profit organizations concerned about the effects of the proposed amendments on the provision of legal services to the poor and the administration of justice. Oral argument will allow this Court to explore both the reasons for the proposal and the reasons for the objections to it.
