Pursuant to Fla. R. App. P. 9.320, the Pro Bono Legal Services Committee of The Florida Bar requests oral argument in this matter. The Committee has a duty to advise the Court on rule changes affecting the administration and provision of pro bono legal service and will offer the Court a high-level perspective on the important access and pipeline pro bono projects that could be significantly hindered by the Proposed Rule.

The Committee's unique vantage point as the entity overseeing and reporting annually on each judicial circuit's pro bono plan will assist this Court in assessing the unintended consequences of the Proposed Rule, which the Committee believes could reduce funding for many programs that reach a broad group of needy Floridians and reduce attorney participation in pro bono legal services.
