## RESPONDENT'S MOTION FOR STAY OF SIXTY DAYS TO BRING A LAWSUIT TO CHALLENGE THE UNCONSTITUTIONALITY OF THESE DISCIPLINARY PROCEEDINGS IN FEDERAL COURT

Respondent, Bruce Jacobs, Esq. ("Jacobs") files his Motion to Stay of Sixty Days to Bring a Lawsuit to Challenge the Unconstitutionality of these Disciplinary Proceedings in Federal Court, and states:

- 1. As set forth in his initial brief, Jacobs respectfully submits these disciplinary proceedings are a sham that violate his First Amendment right to truthfully criticize judges presiding over fraudulent foreclosures who refuse to recuse themselves in violation of the Florida and U.S. Constitutions, the Judicial Canons, and controlling U.S. Supreme Court law.
- 2. Jacobs previously filed a motion to dismiss these proceedings under Florida's Anti-Slapp statute setting forth his First Amendment grounds and other arguments that these proceedings violate Federal and Florida Fair Housing Act whistleblower protections, the selective prosecution doctrine,

and the Ku Klux Klan Act of 1871 which the court struck as unavailable.

- 3. In his Anti-Slapp motion, Jacobs expressly reserved "his right to litigate these federal constitutional questions in federal court under *England v. Louisiana State Bd. of Med. Examiners*, 375 U.S. 411, 84 S. Ct. 461, 11 L. Ed. 2d 440 (1964)."
- 4. Jacobs intends to file a federal action to raise the federal constitutional questions in federal court which could obviate the need for this court to take any further action.

WHEREFORE, Bruce Jacobs Esq., respectfully requests, in the interest of justice and judicial economy, this Honorable Court stay these proceedings 60 days so he may litigate his federal constitutional questions in federal court, and grant any other relief deemed mete and just.
