**NOTICE OF INTENT TO SEEK REVIEW OF REPORT OF REFEREE**

COMES NOW, The Florida Bar, pursuant to rule 3-7.7(c)(1) of the Rules Regulating The Florida Bar and files this Notice of Intent to Seek Review of Report of Referee and says:

1. The Bar requests this court review the report of referee docketed on May 20, 2021.
2. The Referee recommends findings of guilt for violations of Rules 4-1.1, 4-1.2(a), 4-1.3, 4-1.4(a), 4-1.4(b), 4-1.5(e), 4-1.15, 4-1.16(c), 4-1.16(d), 4-3.2, 4-3.3 (a), 4-8.4(a), 4-8.4(c), 4-8.4(d), 5-1.1(a), 5-1.1(b), 5-1.1(e), 5-1.2(b), 5-1.2(d). The Bar does not seek review of the recommendations concerning guilt.
3. The Referee also recommends a 6-month suspension, and payment of the bar's disciplinary costs.


4. At the Executive Committee Meeting of the Board of Governors of The Florida Bar on June 25, 2021, the referee's report was considered, and the Board voted to file a Notice of Intent to Seek Review of Report of Referee as it relates to the recommended discipline.

5. The Florida Bar seeks review of the Referee's recommendation of a 6-month suspension and will ask this Court to impose a one-year suspension along with the remaining recommendations and conditions recommended by the referee.


