**ORDER SCHEDULING STATUS CONFERENCE FOR APRIL 8, 2020**

THIS CAUSE comes before the Court on an order from the Florida Supreme Court. The order requires the court reporters to file and electronically submit transcripts and disks of all proceedings within eighty (80) days of the date of the notice of appeal. The order requires the Clerk to file the record on appeal and all exhibits within twenty (20) days of the date of the filing of the transcripts. The order further requires that this Court hold a status conference within sixty (60) days. Pursuant to the order, it is

**ORDERED AND ADJUDGED** as follows:

1. A status conference hearing is scheduled in this matter for **Wednesday, April 8, 2020 at 8:30 a.m. at the Lee County Justice Center, 1700 Monroe Street, Fort Myers, Florida 33901**. The Court has reserved fifteen minutes for this hearing. The sole issue at this hearing is the status of the preparation of the record on appeal. Counsel for either party should file additional directions or designations immediately if counsel wish additional transcripts or documents added to the record on appeal. **Should the record on appeal be completed and submitted prior to the hearing date, the hearing will be cancelled, as the purpose of the hearing will be fulfilled.**

2. **The Clerk of Court, or a representative thereof with knowledge of the status of the Clerk's compliance with the order, is required to appear in person.**

3. **A representative of Martina Reporting Services with knowledge of the court reporters' compliance with the order is required to appear in person.**

4. Counsel for the parties may arrange attendance at the status conference hearing by means of a conference telephone call. In the event that the parties wish to participate by telephone, they may do so only if they file a written request in accordance with Fla. R. Jud. Admin. 2.530, no later than five (5) days prior to the status conference. All such requests shall be filed with the Clerk of Court, with courtesy copies provided to the Court and to all other counsel of record. The parties should note that any timely request to appear via conference call will be honored and that no court order will be entered in response.

5. **Parties who appear by telephone must abide by the following procedures. All participants are directed to call the toll free telephone number (1-888-585-9008) at precisely 8:30 a.m. Participants should then enter participant code number 844-496-716, followed by the pound (#) sign. Next, participants will be prompted to state their name, thereby completing the connection. Thereafter, the chairperson will initiate and facilitate the conference, and the call will end when the chairperson ends the call.**

6. Parties are advised that the Court cannot be responsible for any technological difficulties that may arise should counsel wish to attend by telephone.

7. As there will be no testimony taken at the status conference hearing, the Defendant's presence is not needed. Accordingly, Defendant will not be transported from the Florida Department of Corrections to the Lee County Justice Center for the status conference hearing.
