**REPORT ON STATUS CONFERENCE HELD ON APRIL 8, 2020**


THIS CAUSE comes before the Court on an order from the Florida Supreme Court. Pursuant to that order, a status conference was held on April 8, 2020, for the purpose of determining the status of preparation of the record on appeal. Those present at the status conference included: a Deputy Clerk of Court; trial counsel Michael Mummert; Amanda Lopez, a representative of Martina Reporting Service; Hamid Hunter and Cynthia Ross, Assistant State Attorneys; and Scott Browne, Assistant Attorney General.

Ms. Lopez stated that the last transcript was being prepared from the supplemental designation, and would be completed before May. The deputy clerk advised that the record on appeal would be completed on or before April 17, 2020, and was waiting only on the transcript and report from this hearing. She did not foresee anything that would prevent the timely filing of the record on appeal. Since appellate counsel was not present, some of the clerk's questions to the parties could not be answered. Mr. Mummert brought up an issue with court exhibit 4, the proffer of Mr. Wright on CD, being blank. The Court directed the parties to resolve that issue and stipulate to submit a valid CD. The Court indicated that a supplemental hearing would be held at a later date, to ensure that appellate counsel had no additions to the record, or other issues.
