**MOTION FOR REHEARING**

Laura A. Roe, Chair of the Appellate Court Rules Committee ("Committee"), and Joshua E. Doyle, Executive Director of The Florida Bar, file this motion for reconsideration of this Court's January 6, 2022, decision adopting the recommendation of the Committee and amending Florida Rule of Appellate Procedure 9.130 to permit interlocutory appeals from orders granting or denying a motion for punitive damages.

Rule 9.130 was before the Court in two recent cases, SC20-1871 and SC21-129. In each case, the Committee recommended several grammatical updates to the rule in conjunction with its substantive proposals to add two new categories of orders to the list of orders subject to interlocutory review. The Court declined to adopt rule amendments in SC20-1871. When issuing its ruling adopting the Committee's proposed amendments in the present case, this Court may have overlooked these minor grammatical changes to the rule necessitated by the addition of a subdivision to the rule language. The Committee respectfully requests that this Court reconsider adopting the Committee's proposed grammatical revisions, as reflected in Appendix A, attached hereto.
