
NOTICE OF HEARING AND ORDER TO APPEAR

THIS MATTER came before the Court, pursuant to an Order from the Supreme Court of Florida in Case No. SC21-1779. The Order was dated January 4, 2022, and it was filed in this Court on January 4, 2022. The Supreme Court of Florida received a notice of appeal in this case which is an appeal from a first-degree murder conviction with a sentence of death. The Court, having reviewed the Order from the Supreme Court of Florida, the case files, and applicable law, finds as follows:

The Order from the Supreme Court Of Florida, pursuant to Florida Rule Of Appellate Procedure 9.142(a)(1), appoints the Chief Judge of the Tenth Judicial Circuit to monitor the preparation of the complete record in the Circuit Court for timely filing in the Supreme Court of Florida. That Order also directs Circuit Court Judge Donald G. Jacobsen to take such action as may be necessary to ensure that a complete record on appeal is properly prepared and filed. The Florida Supreme Court has directed this Court to hold a status conference which shall be attended by the Clerk of Court (or the clerk's designee), all appropriate court reporters, counsel, and such other persons the Court may deem necessary.

Therefore, the Court directs the Clerk of Court (or the clerk's designee), counsel, and the following named Court Reporting services to attend a **status conference** on **February 25, 2022**. The Court Reporting services that are directed to attend this status conference are as follows: McGill & McSwain, Wasilewski Reporting, Reliable Court Reporting, Electronic Court Reporting, and Coker Court Reporting. The **status conference** is scheduled to begin at **8:30 a.m.**, in **Courtroom 7D**, Polk County Courthouse, 255 N. Broadway Avenue, Bartow, Florida 33830, before the Honorable Donald G. Jacobsen, Circuit Judge.
