COMES NOW Respondent, Honorable Marni A. Bryson, by and through the undersigned counsel, and files this Motion to Appear by Video Conference/Zoom and states as follows:

Respondent has been directed to appear before this Court on Wednesday, February 9, 2021, at 9:00 a.m.

For health and safety considerations, and consistent with Supreme Court of Florida Administrative Order No. AOSC21-17, Amendment 2 In Re: Covid-19 Health and Safety Protocols and Emergency Operational Measures for Florida Appellate and Trial Courts (July 29, 2021), Respondent's counsel requests the Court to conduct the proceeding remotely, allowing the parties to utilize existing technology for this purpose

Due to the continuing increase in COVID-19 cases in Florida, Respondent and Respondent's counsel are concerned about the spread and potential health impact of COVID-19 and the "Omicron" variant, increasing the concern over travel and in-person interactions.
