**AMENDED NOTICE OF FORMAL CHARGES**

The Investigative Panel of the Florida Judicial Qualifications Commission, by a vote of the majority of its members, pursuant to Rule 6(f) of the Rules of the Florida Judicial Qualifications Commission and Article V, Section 12(b) of the Constitution of the State of Florida, finds that probable cause exists for formal proceedings to be instituted against you.

*“The judicial duties of a judge take precedence over all the judge’s other activities.”*

*“The failure of any judge to comply with an administrative order or directive of the Chief Judge is considered neglect of duty...”*

*“The chief judge in each circuit shall separately communicate to all trial court judges in that circuit the importance of a professional work ethic and accountability to the judiciary as a full-time commitment under the [Code of Judicial Conduct] and the Constitution of Florida.”*

1. You failed to devote full time and attention to your judicial duties during periods of 2016. You were absent from the courthouse and not otherwise working full time on a recurring basis.
2. You failed to devote full time and attention to your judicial duties during periods of 2017. You were absent from the courthouse and not otherwise working full time on a recurring basis.
3. You failed to devote full time and attention to your judicial duties during periods of 2018. You were absent from the courthouse and not otherwise working full time on a recurring basis.
4. You failed to devote full time and attention to your judicial duties during periods of 2019. You were absent from the courthouse and not otherwise working full time on a recurring basis.

5. You did not properly notify the Chief Judge of your absences or keep adequate records of your leave time between 2016 and 2019.

Your actions constitute violations of the provisions of Canons 1, 2A, 3B(2), 3B(4), 3B(8) and 3C(1) of the Florida Code of Judicial Conduct and Art. V, §13 of the Florida Constitution, Canon 3A and Florida Supreme Court Admin. Order 2014-66, and Palm Beach County Admin. Orders 11.107-9/08 and 11.107-01/18.

You are hereby notified of your right to file a written answer to these charges within twenty (20) days of service of this notice on you. The original of your response and all subsequent pleadings must be filed with the Clerk of the Florida Supreme Court, in accordance with the Court's requirements. Copies of your response should be served on the undersigned Special Counsel for the Judicial Qualifications Commission.
