

The Honorable Stephen G. Henderson, as referee, shall hear, conduct, try, and determine matters presented and shall submit findings of fact and recommendations to the Supreme Court of the State of Florida as provided in Rule 3-7.6(m) and in accordance with the June 16, 2021 order of Chief Justice Charles T. Canady. The referee's report shall be filed in accordance with said order.
