She has accepted the Chief Judge’s designation to make argument confined to (1) the Thirteenth Circuit’s Differentiated Case Management System, (2) the desirability of a uniform docket management system with functionality similar to the PACER/CMECF system in order to bring the Thirteenth Circuit into timely compliance with the proposed rule change relating to motions, and (3) any questions the Court may have.
