Respondent, Daniel Markovich, pursuant to Rule 3-7.2(k) of the Rules Regulating The Florida Bar, files this notice of waiver of time limitation for conducting final hearing and the filing of the referee's report and recommendation and in support thereof submits to this Honorable Court as follows:

1. On April 7, 2033, The Florida Bar filed a Notice of Determination or Judgment of Guilt regarding Respondent.

2. On April 28, 2022, the Supreme Court of Florida entered an order suspending Respondent.
